Supt. Report

Supt. Froebe reported on the following: The new chillers were installed over Spring Break. A representative from Carrier was on site last Thursday to get them up and

running. TCI actually finished up the drilling portion of the borefield work early last week. They still anticipate being completely finished and the fences down sometime towards the middle of May. We had a water leak in the basement of the District office the day before Spring Break. Many of our old financial documents were damaged and ServPro was needed to help dry out the impacted areas. The principals, their staffs, Mrs. Phillips, and Mrs. Coffey deserve a ton of credit for once again successfully administering the IAR assessment. Having all grades 1-to-1 has really helped simplify the testing process. The buildings have been holding their spring Problem Solving Team meetings to determine if interventions have been working and to determine next steps. We received our most recent sales tax payment for the month of January in the amount of \$53,424.04. We will be holding our first negotiations meeting with LEEO tomorrow regarding a new contract. I am continuing to explore options along with some other area superintendents in regards to an alternative school in Lincoln. Connie and Colleen presented this past Friday in Peoria at a "Farm to School Conversation" held by the Regional Food Council. There were many superintendents and food service directors from the Peoria area on hand to learn about our scratch cooking initiative. Member Bates made a motion, seconded by Member Stoltzenburg, to approve the report as presented and recommended by Supt. Froebe. Members Bates, Hullinger, Williams, Stoltzenburg, Kutz, Montgomery, and Rohrer voted aye to a roll call vote. Motion carried.
